

Ruin Probabilities for Risk Models with Constant Interest

Abstract: In this paper, we consider risk models in continuous time of insurance companies. We show that the ruin probabilities still have exponential form whilst assuming that the claim sizes are dependent random variables. In addition, more general models of ruin probabilities where effects of interest are constant are considered. The proof follows the Martingales method.
